UNEMPLOYMENT ASSISTANCE IN 2021 FOR ANGELENOS AFFECTED BY COVID-19

If you were laid off, furloughed, had your hours reduced or are unable to work due to COVID-19, you may be eligible to receive assistance payments through the State of California's Employment Development Department (EDD). These benefits are available to California residents who have authorization to work in the U.S. and meet other eligibility requirements.

PROGRAMS AVAILABLE & PAYMENT AMOUNTS

The following common assistance programs are available to eligible California residents:

- Unemployment Insurance (UI) benefits ranging from \$40 to \$450 per week (UI benefits are the most common weekly unemployment insurance payments for workers who lose their job or have their hours reduced through no fault of their own. Depending on your weekly benefit amount, you may be able to receive benefits for up to 26 weeks.)
- Pandemic Unemployment Assistance (PUA) benefits of up to \$450 per week (If you are not eligible for regular UI assistance, you may qualify for PUA benefits if you are an independent contractor, freelancer, self-employed worker, business owner, or gig worker and only received a 1099 tax form. These recently extended payments may be provided for up to 11 weeks through mid-March 2021.)
- Pandemic Emergency Unemployment Compensation (PEUC) benefits of \$300 per week (PEUC benefits provide a supplemental payment for a limited number of weeks. PEUC is in addition to the weekly unemployment benefits amount, such as UI or PUA payments. These recently extended payments may be provided for up to 11 weeks through mid-March 2021.)
- **Disability Insurance (DI)** benefits ranging from \$50 to \$1,357 per week (You may be eligible for DI benefits if you are unable to work because you have been diagnosed with COVID-19 or have symptoms related to COVID-19. Generally, you may be eligible if you are unable to work due to a non-work-related illness, injury or pregnancy.)
- Paid Family Leave (PFL) benefits ranging from \$50 to \$1,357 per week (You may be eligible for PFL benefits if you are unable to work because you are caring for a family member who is diagnosed with COVID-19 or has symptoms related to COVID-19.)
